Basic Educational Services: services provided to approximately 170 Native American students through teachers, para-educators, bus drivers, facility personnel, cooks, administration and support staff. Expenses include staff salaries and benefits, supplies, equipment, outside services, travel and training, student activities, community and parent involvement, utilities, transportation expenses, maintenance and repair, food and supplies for breakfast, lunch and snack programs.

4b (Code:) (Expenses \$ 503,677 including grants of \$) (Revenue \$)

Family and Child Education (FACE) / TANF Adult Ed and After School Program / 21st Century:

FACE: service provided to Native American birth to age 5 children with involvement from parents and guardians. Expenses include salaries and benefits for staff, travel/training, supplies, equipment, transportation, special events, technology.

TANF Adult Ed: provides GED prep and testing, job readiness, and college prep courses to adults. Expenses include staff salaries and benefits, testing supplies and other misc. supplies, travel/training and equipment.

TANF Sponsored After School Program: provides academic and recreational activities Monday through Thursday when school is in session and supports a 6 week summer academic program. Expenses include staff salaries and benefits, travel and training, supplies, equipment, and special events. The AS program was in session 108 days during this audit period with an average daily attendance of 53 students. Due to staffing shortages the program was for K-3rd grade Tuesday's & Thursday's and for 4th-8th grade Monday's and Wednesday's.

21st CCLC: provides additional support to the AS program and funds a 6-week summer academic program. Expenses include staff salaries and benefits, travel/training, supplies, equipment, summer staff and benefits, field trips. The summer program was in session 24 days with an average daily attendance of 66 students.
